The **CERM** Team provided operational emergency response work that included environmental management and safety monitoring in designated areas affected by the spill. We deployed 80 team members to manage the documentation of safety investigations and project safety protocols. The team was also responsible for promoting safety and compliance, executing communications with emergency response personnel and leaders, and managing beach clean-up and boom deployments. **CERM** takes pride in its contribution to the Gulf's recovery.

MARTA Laredo Solar Station Atlanta, GA

The Laredo Bus Facility is the largest solar PV installation in Georgia. MARTA selected the New South Construction and Circle D Enterprises Joint Venture as its design-build contractor, and the construction joint venture selected **CERM** to be a part of its design-build team. **CERM** provided survey construction layout, geotechnical engineering consultation, and construction materials testing services for soil, concrete, and structural steel. The energy-efficient solar panels are mounted on structural steel canopies located in the bus parking area. The panels are anticipated to generate 1,200,000 kilowatt hours of electricity annually, and the energy generated will offset the cost of the electricity used by the facility.



Mobile Gas Service Corporation (MGSC), Mobile Manufactured Gas Plant Community Mitigation/Engagement Mobile, AL

CERM is currently providing technical and managerial leadership in connection with the planning, site assessment, community mitigation engagement, risk analysis, and remediation activities of a 10-acre former manufactured gas plant site in Mobile, Alabama. MGSC intends to remediate the property for use as public greenspace. As part of the ongoing community mitigation/engagement phase, CERM is working in partnership with residents, businesses and other key stakeholders towards the site's transformation into an inviting, productive and beneficial development.
